

G. relative to the non-attendance of Dr MacGrath upon a Dispensary Midwifery case, and requesting the observations of the Guardians thereon.

Mr Gerry's letter was practically a copy of the Guardians Minutes of the 11th instant ultimo, (pages 249 + 250) relative to this matter, together with a reasoned statement of the facts of the case as they appeared to Mr Gerry, and the concluding paragraph introduced the case of Mrs John Sweeney of Swillybrin a Midwifery case which occurred on the 29th Day last, and alleged that Dr MacGrath declined to attend the patient but sent the messenger for the Midwife.

Moved by Mr M. Dwyre and seconded by Mr McGinley :-

" That the whole matter be declared closed so far as the Board of Guardians is concerned." As an amendment Mr M. J. Madden moved and Mr Gerry seconded :-

" That the matter be referred to the Local Government Board for their decision."




