Under these circumstances he now proposed that the salary of Doctor Whullin Workhouse Medical Officer be increased from £70. to £90. per year to take effect as from today, and that ~~he should receive~~ This was seconded by Mr J Keon and passed unanimously.

The first amendment having been declared lost and the second withdrawn the Chairman then proposed and seconded of the original resolution with the unanimous consent of the members agreed to amend the resolution by adding thereto the amendment of Mr Forigan to increase the Workhouse Medical Officer's salary to £90. as from today and the triennial increments of £15. be granted to him on such salary.
