Place a sheet of one-sided carbon paper, face downwards, between the first and second leaves, and then the sheet of black board after the Duplicate. Write upon the first leaf with a Duplicator or Manifold Slip Pen, and two copies will be the result.

In the case of a Triplicate Book, a sheet of two-sided carbon paper is placed between the 2nd and 3rd leaves, and then proceed as above.

A CARBO-PLATE can also be supplied to take the place of the black board. This is a plate which grips the carbon, and at the same time provides an extra hard plate, made of aluminium, which gives an extra clear copy, and enables the carbon paper and support to be placed in position for writing and withdrawn without touching the carbon with the hands.

Read Letter from the L.G. Board, dated 19th Sept. 1916, N^o. 43427, sanctioning the expenditure of 10/6 for the testing of the samples of tea from the Workhouse.

Read Letter from the L.G. Board, dated 28th Sept. 1916, N^o. 46071, sanctioning payment of 12/6 as remuneration to Nurse Teresa Ward in connection with her employment in the Fever Hospital for a day and night at 1st August last, together with 12/9 travelling expenses.

Read Letter from the L.G. Board, dated 21st Sept. 1916, N^o. 43752, stating that outdoor relief may be allowed in the case of Mary Moore if she comes within the classes mentioned in section 1 of 10 Vic. Cap. 31, as eligible for such relief. As regards separation allowance, they forwarded an Army Order dated 26th Feb. 1915 and suggested that the facts of the case should be brought before the Regimental Paymaster of the regiment in which Mrs. Moore's son is serving.

Read Circular Letter from the L.G. Board, dated 12 Sep. 1916, N^o. 42672, drawing attention to the Time (Ireland) Act, 1916, under which Western European Time is to be observed throughout Ireland from & after 1st October 1916, and stating that all clocks should be put back 35 minutes at 3 a.m. on night of 30th Sept. 1916

Read Letter from the L. G. Board, dated 14th Sept. 1916, No 43785, forwarding the report of the Auditor, Mr. Cosgrave, on his audit of the Union Accounts for the Half-year ended 31st March 1916, together with an attested Abstract.

Read Letter from Nurse O'Donnell, Fever Hospital, dated 2nd October 1916, applying for holidays.

That Hugh Loland, Shoemaker, had soled 2½ pairs boots, heeled 4½ pairs and patched 4½ pairs @ contract rates. That Henry Carey was employed 6½ days building turf stacks at the sanctioned rate of 3/6 per day. That D. McFloskey Saddler had done slight repairs to the ambulance harness. That Wm O'Fonnoy, blacksmith had repaired the potato basket @ 3/-, a grate @ 2/6 and pointed a pick and crow bar @ 1/-

The Master also reported that he had procured 1st peas, 1 dozen lamp glasses, 1 doz sets knitting needles, 1 Bag cement and 2 gross trouser buttons

dated 28th Sept. 1916

Read letter from Mr. Wm. J. Doherty, C.E., stating that Mr. James Kelly, the contractor for additions to the Infirmary for Isolation Wards for Consumptives had arranged to start work on 2nd October 1916.

Also a further letter dated 8th October 1916 stating he intended to inspect the work on 9th inst.

Mr. Cole referred to a recommendation made by L. G. B. Inspectors and Inspectors of Lunatics for the removal of the cells in the two Idiot Wards and he thought it would be an opportune time to deal with them.

On the motion of Mr. Scott, seconded by Mr. Cole it was unanimously agreed that an extra payment of Two Pounds be allowed to the contractor for removing one cell in each Idiot Ward and putting everything right afterwards to the Architect's satisfaction, the remaining cells in each ward to be retained for emergency cases.

Read letter from Mr. James O'Hara, Dublin dated, 3rd October 1916 stating that he had examined samples of the six chests of tea delivered at the Workhouse and found them same as sample $\frac{77}{22}$ tendered.

Read letter from Mr. Robert Wilson, Lashel dated, 9th October 1916 asking for an increase of three pence per gallon for the sweetmilk supplied to the Workhouse bringing the price up to $1\frac{1}{2}$ per gallon, the increase to run from 1st November 1916 to 1st May 1917 owing to the high price of feeding stuffs.
